# Melville Agri-Park Futurity & Derby – Rules & Regulations

1. **Futurity Minimum \$4000 added** – Open to any horse which is a foal of 2005 and later (5 years & under). Horse must never have competed in any barrel race, rodeo, jackpot or other futurities before December of the previous year. Horses may have run exhibition runs.
2. **Derby Minimum \$3000 added** – Open to any horse which is a foal of 2003 and later (7 years & under).
3. **Futurity & Derby** – Photocopy of front and back of registration papers on registered horses must accompany nomination. Veterinarian affidavit of year of birth and complete description of unregistered horses must accompany nomination.
4. Futurity and Derby will be TWO runs and a final go. Top 10 on 2 runs will qualify for the finals. Champions will be declared on 3 Go Average.
5. Running order will be drawn for the 1<sup>st</sup> go. 2<sup>nd</sup> go will run in reverse order. Short go will run in order qualifying, slowest to fastest.
6. Nomination payments are due **July 15, 2010** and **August 15, 2010**. Payments are to be made by two post dated cheques or one cheque in full amount and must accompany entry forms. **Late fines will be \$50.00/payment. All entries must be received in office by August 30, 2010 to make the programs.**
7. All cheques made payable to **Melville Agri-Park** mailing address PO Box 2678 Melville, SK S0A 2P0
8. Any NSF's cheques will carry a \$35.00 Service Charge. All Late Entries Payable in Cash; no exceptions.
9. Substitutions will be accepted for death, illness or unsoundness. Veterinarian Affidavit of proof must accompany substitutions along with a \$50.00 fee. Substitution of rider is allowed with no additional fees, provided office is notified prior to 1st go. **NO REFUNDS FOR ANY REASON.** If warranted, form to be completed and refund will be mailed.
10. **PAYOUT – FUTURITY & DERBY:**

1 <sup>st</sup> & 2 <sup>nd</sup> Go	1D – 25% of Total Prize Money
	2D – 5% of Total Prize Money
Short Go	– 15% of Total Prize Money
Average	– 25% of Total Prize Money

## **11. RUNNINGS RULES & REGULATIONS –**

- Entrants / competitors and owners will be responsible for themselves and their horses. All horses may be subject to a drug test, examination to meet registration identification or examination for age at the discretion of management. Any horse examined and found to be of ineligible age, failing to meet registration description or failing to pass a drug free exam will be disqualified.
- Inhumane treatment of horses will not be tolerated on the grounds and will result in disqualification.
- **Competitors must be ready when called or they will forfeit their run.**
- **No circling in the arena prior to your run**
- **Owner to appoint who gets the winnings check**
- **No barrel work except during Time Only runs; open riding time allotted with no barrels**
- Completion of entry form or payment of entry fees will indicate acceptance of all rules and regulations governing this event.
- All questions/inquires to the office personnel only. All decisions made by office are final.
- Notwithstanding anything to the contrary herein contained it is understood that each contestant / owner waives all claims against the Melville Agri-Park Barrel Futurity, organizing body, workers, etc. for any injury, loss of damage which may result in anyway from the operations of activities of the Melville Agri-Park Barrel Racing Event.
